* A qualifying educational institution is a fundamental Christian college or university that meets the description of an educational institution described in Section 170(b)(1)(A)(ii) of the Internal Revenue Code, to wit: an educational institution which normally maintains a regular faculty and curriculum and normally has a regularly organized body of students in attendance at the place where its educational activities are carried on. Such educational institutions include secondary schools, colleges and universities.

Please submit the following with this application:

1) Your personally written testimony of faith in Christ

2) Three recommendations from references who have known you for at least two years—one reference must be your pastor and the other two should not be related to you. Each reference should explain why you qualify for a scholarship from DNSF and needs to include his or her name, address and phone number.

3) International students—please submit your parents' tax forms or provide a statement of explanation about family income.

Grantees shall use grants to pay tuition required for enrollment, fees, books, supplies and equipment required for courses of instruction at the qualifying educational institution. If the scholarship is awarded, funds will not be released until you are enrolled in the qualifying educational institution.

Returning Applicants: If you have received funds in prior years and are reapplying to DNSF, we will need a new application, parents' latest tax form and a FAFSA.
