

Grantees shall use grants to pay tuition required for enrollment, fees, books, supplies and equipment required for courses of instruction at a qualified, independent, fundamental Christian educational institution.

Please note that under federal law, donors to a scholarship fund are not able to designate or recommend any particular recipient and that all selection for scholarships is made by the three independent trustees of the Fund.

The Demonstrative Need Scholarship Fund has been recognized by the IRS as tax-exempt under Section 501(c)(3) and is a public charity to which foundations and corporations as well as individuals may make tax-deductible contributions.

In addition to cash, you may wish to consider tax-deductible gifts of stocks, bonds, securities, mutual funds or other property or gifts through your estate, life insurance, IRA, 401(k), or a charitable trust. For more information regarding giving options, please contact the DNSF Board Liaison.

## DEMONSTRATIVE NEED SCHOLARSHIP FUND

The purpose of the **Demonstrative Need Scholarship Fund** is to grant scholarships and fellowships to qualified students in order to enable more of them to study at independent fundamental Christian educational institutions and to be prepared in the essentials of knowledge and the Christian faith. In order to effectuate these purposes, the group from which grantees shall be selected shall meet the following criteria:

- 1)** Potential grantees shall be accepted at a qualified, independent, fundamental Christian educational organization, such as Bob Jones University.
- 2)** Potential grantees shall have demonstrated academic ability and spiritual leadership.
- 3)** Potential grantees shall have demonstrated financial need.
